

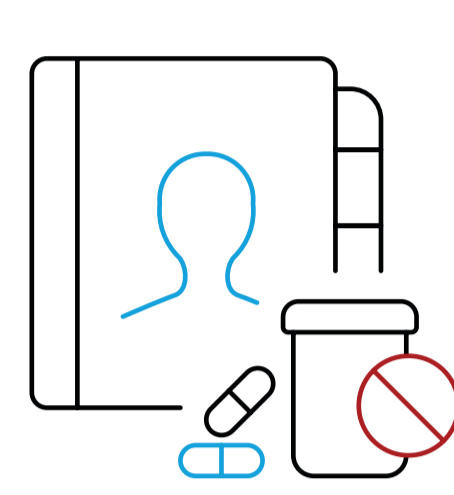

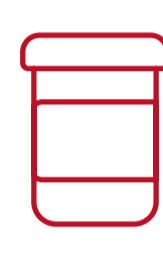
Member Compliance Remains a Significant Challenge

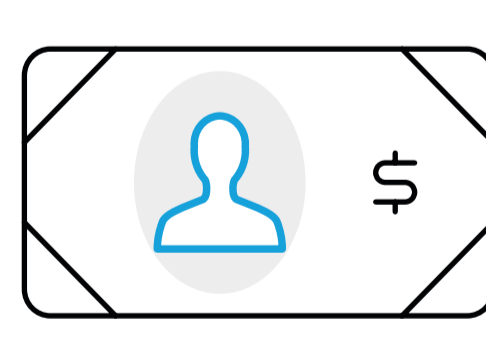

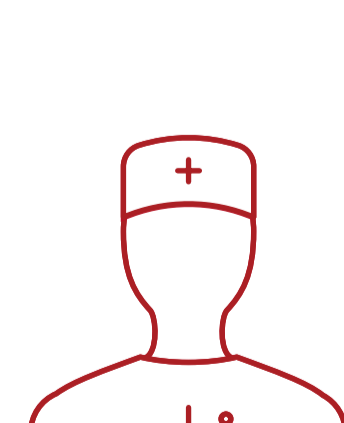
